The DuluxGroup Site is the main Australian head office for Dulux and their affiliated companies.

Contract history

The original contract was awarded to Tungsten FM in 2004, with Programmed acquiring Tungsten FM in 2008. Programmed's reliability and performance resulted in a contract extension being awarded in 2018.

The FM services performed under the current contract includes: HCAV, electrical, mechanical, plumbing and gas, fume cupboards, grounds, pest control, and sanitation services. The team also assist with daily operational checks of specialised equipment and assists in some production of products used for testing in the Innovation Centre.

Building portfolio

Head Office: Dulux' corporate headquarters has over 700 employees, and is the site for the Programmed team and Help Desk

Innovation Centre: Used by the Dulux Research and Development team and runs 24/7/365 due to year-round testing.

Barncastle: A warehouse built for WW2 operations and moved from Moorabbin Airport in the 1950s, used for storage.

Value add
