Purpose: Vendor User Management (VUM) is the centralised platform used to activate user profiles and manage access for Supervisors and Technicians. This process is essential for enabling users to access and operate the **Touchstone Mobile App** effectively.

By following this guide, you will be able to ensure users are correctly set up and equipped to use the Touchstone Mobile App in alignment with their assigned roles and responsibilities.

Primary Use: This Work Instruction specifically supports two key scenarios:

1. Activating a user profile in the Touchstone Mobile App.
2. Downloading and setting up the Touchstone Mobile App on a smart device or desktop.

Business Unit Application: This Work Instruction applies to Programmed Facilities Management (PFM).




Before you start:



- Ensure you have received the email invitation containing a link to Activate your Touchstone Mobile account.
- If no email has been received, please ask your Vendor or PFM Supervisor to resend the email invitation to you.

Activating your User Profile via the Vendor User Management system:

Explanation	Screenshot
<p>Accessing the Platform</p> <p>To begin, click the link provided in your email invitation. This will direct you to the login screen, which will appear as shown.</p> <p>Click Send Verification Code.</p>	
<p>A six-digit code will be sent to your email address.</p> <p>Enter the Verification Code and click on Verify Code.</p>	
<p>Once the Verification Code has been entered, your email address will be verified.</p> <p>Click on Continue.</p>



<p>External Vendors should select the Sign-in with email option as shown.</p> <p>Once you are logged in, enter your email address.</p> <p>Enter a new password, then reconfirm this password.</p> <p>PFM staff should select the Sign-in for Programmed Staff option and enter their usual work password.</p> <p>Click Continue.</p>	 
<p>Result: You will be directed to the Download Overview screen.</p>	

Downloading the Touchstone Mobile Application on a smart device.

There are several ways to download the Touchstone Mobile App onto a device:


1. For Android devices, click this link to download Touchstone via Google Play: [Touchstone Mobile App](#)
2. For Apple devices, click this link to download Touchstone via the Apple Store: [Touchstone Mobile App \(Apple\)](#)
3. Alternatively, if you have been setup in VUM (post go-live), Click **Download Touchstone** and then select either:
 1. **Google Play** for Android devices or;
 2. **App Store** for Apple devices

To download the Touchstone Mobile App to a desktop, click **Touchstone Mobile (Windows)**.
